

## HOMETOWN POSTCARDS CONTEST RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

### 1. Eligibility

Hometown Postcards Contest (the "Contest") is open to legal residents of Pennsylvania who are at least eighteen (18) years old at the time of entry. Employees of Pennsylvania Cable Network and other companies associated with the promotion of the Contest, and their respective agents, subsidiaries, affiliates and advertising and promotion agencies as well as the immediate family (spouses, parents, siblings, and children) and household members of each such employee are not eligible. The Contest is subject to federal, state, and local laws.

### 2. Sponsor

The Contest is sponsored by Pennsylvania Cable Network ("PCN"), located at 401 Fallowfield Road, Camp Hill, Pennsylvania 17011.

### 3. Agreement to Comply with the Rules

Participation in the Contest constitutes entrant's full and unconditional agreement to and acceptance of these Rules and the decisions of PCN, which are final and binding. Winning a prize is contingent upon being compliant with these Rules and fulfilling all other requirements set forth herein.

### 4. Contest Period

The Contest begins on September 01, 2019 at 11:59 PM Eastern and ends on October 01, 2019 at 11:59 PM Eastern (the "Contest Period"). Entries that are submitted before or after the Contest Period will be disqualified. Submissions will be accepted for the duration of the Contest.

### 5. How to Enter

All submissions must be made online. This method of entry will be available by visiting our website ([www.pcntv.com/hometown-postcards](http://www.pcntv.com/hometown-postcards)) and following the directions provided to fill out the entry information, and submit.

Limit one (1) entry per person, per email address, and per household for the duration of the Contest Period. All entries become the property of PCN and will not be acknowledged or returned.

### 6. Prize Drawing

On or about October 04, 2019, PCN will select potential winners in a random drawing from among all eligible entries received. The odds of being selected depend on the number of entries received. PCN will attempt to notify the potential winner via telephone or email on or about October 04, 2019. If the potential winner cannot be contacted within five (5) days after the date of the first attempt to contact him/her, PCN may select an alternate potential winner in his/her place at random from the remaining non-winning, eligible entries.

### 7. Winner Notification

The potential winners will be notified by email, mail or phone. Each potential Grand and First Prize winner (or a parent/legal guardian if the entrant is a minor in his/her state of residence) will be required to complete, electronically sign, and submit a Declaration of Compliance within five (5) days of the date the notice is sent, in order to claim his/her prize. If a potential winner cannot be contacted, or fails to submit the Declaration of Compliance within the required time period, or if a prize is returned as undeliverable, the potential winner forfeits the prize. If the potential winner is at least 18 but still considered a minor in his/her jurisdiction of residence, PCN reserves the right to award the prize in the name of his/her parent or legal guardian, who will be required to sign the Declaration of Compliance on the potential winners behalf and fulfill any other requirements imposed on winner set forth herein.

Potential winners must continue to comply with all terms and conditions of these Rules and winning is contingent upon fulfilling all requirements. In the event that a potential winner is disqualified for any reason, PCN will award the pertinent prize to an alternate winner by random drawing from among all remaining eligible entries. Only three (3) alternate drawings will be held, after which the prize will remain un-awarded. Prizes will be fulfilled approximately 8-10 weeks after the conclusion of the Contest. NOTE: The age of majority in Pennsylvania is 21 years.

## **9. General Conditions**

In the event that the operation, security, or administration of the Contest is impaired in any way for any reason, including, but not limited to fraud, virus, bug, worm, unauthorized human intervention or other technical problem, or in the event the Contest is unable to run as planned for any other reason, as determined by PCN in its sole discretion, PCN may, in its sole discretion, either (a) suspend the Contest to address the impairment and then resume the Contest in a manner that best conforms to the spirit of these Rules or (b) terminate the Contest and, in the event of termination, award the prizes at random from among the eligible, non-suspect entries received up to the time of the impairment. PCN reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to damage the website or undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, PCN reserves the right to seek damages (including attorney's fees) and any other remedies from any such person to the fullest extent permitted by law. Failure by PCN to enforce any provision of these Rules shall not constitute a waiver of that provision.

## **10. Release and Limitations of Liability**

By participating in the Contest, entrants agree to release and hold harmless PCN, and each of its respective agents, subsidiaries, affiliates, advertising and promotion agencies, other companies associated with the Contest, and each of its respective officers, directors, employees, shareholders, representatives, and agents (the Released Parties) from and against any claim or cause of action arising out of participation in the Contest or receipt or use of the prize (including any travel or activity related thereto), including, but not limited to: (a) any technical errors associated with the Contest, including lost, interrupted or unavailable Internet Service Provider (ISP), network, server, wireless service provider, or other connections, availability or accessibility or miscommunications or failed computer, satellite, telephone, cellular tower or cable transmissions, lines, or technical failure or jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures or difficulties; (b) unauthorized human intervention in the Contest; (c) mechanical, network, electronic, computer, human, printing or typographical errors; (d) application downloads, (e) any other errors or problems in connection with the Contest, including, without limitation, errors that may occur in the administration of the Contest, the announcement of the winner, the cancellation or postponement of the event and/or the flyover, if applicable, the incorrect downloading of the application, the processing of

entries application downloads or in any Contest-related materials; or (f) injury, death, losses or damages of any kind, to persons or property which may be caused, directly or indirectly, in whole or in part, from entrants participation in the Contest or acceptance, receipt or misuse of the prize (including any travel or activity related thereto). **11. Disputes**

Except where prohibited, each entrant agrees that any and all disputes, claims and causes of action arising out of, or connected with, the Contest or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in Pennsylvania. All issues and questions concerning the construction, validity, interpretation and enforceability of these Rules, entrants rights and obligations, or the rights and obligations of PCN in connection with the Contest, shall be governed by, and construed in accordance with, the laws of Pennsylvania, without giving effect to any choice of law or conflict of law rules, which would cause the application of the laws of any jurisdiction other than Pennsylvania.
